Dear Mr. Buckley:

This letter is in response to your request for additional information regarding the above referenced report.

We have amended the Year End Report to correct the beginning cash balance and the totals listed on Lines 6(c), 11(a)(i), 11(a)(ii), 11(a)(iii), 11(c), 11(d), 19 and 20, Column B of the Summary and Detailed Summary Page(s).

Schedule A has also been amended to correct data entry errors made regarding in-kind contributions.

Schedule A supporting Line 17 discloses payment(s) from American List Counsel, Inc. in consideration for the rental of lists that were developed by the Committee for its own political and campaign purposes. These payments reflect the usual and normal charge for the lists, which have an ascertainable value. The amounts of the payments were determined by looking to the amounts paid for similar lists under normal commercial practices. The Committee also receives payment(s) from individuals for goods and/or services, including equipment and supplies. The amounts for these payments are determined by looking at the fair market value of similar goods and/or services.

All descriptions for purpose of disbursement on Schedule B supporting Line 21(b) have been updated to clearly identify each disbursement. None of these expenditures were made on behalf of federal candidates.

Schedule B has been amended to include corresponding entries for earmarked contributions disclosed on Schedule A supporting Line 12.

Additional text has been provided on Schedule D to further clarify the Shorr Johnson Magnus Media credits. Also, all independent expenditures disclosed on 24-hour notices have been itemized on Schedule E or Schedule D.

Coordinated expenditure(s) made on behalf of Bobby Neal Bright, Sr., R. Parker Griffith, Elizabeth Markey, Raul Martinez, Daniel J. Seals, Paul J. Carmouche, Frank Kratovil and Glenn Carlyle Nye III, reported on Schedule F supporting Line 25 were related to expenses incurred prior to and including General Election Day. These expenses were charged on reoccurring billing statements, paid upon receipt of invoice(s) as agreed or the expense was added to the appropriate Schedule D, if applicable.

The Committee received additional spending authority from the Democratic State Central Committee of Louisiana. Therefore, coordinated expenditures made on behalf of Paul Carmouche totaling \$56,058.11, were within the limitations.
