This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your calculations for Administrative/Voter Drive EVENT YEAR-TO-DATE totals are incorrect. EVENT YEAR-TO-DATE totals for administrative and voter drive costs are derived by aggregating all disbursements during the calendar year within the category, not by individual purpose such as "Utilities" or "Contract Fee". Please amend your report by providing the correct Administrative/Voter Drive EVENT YEAR-TO-DATE totals.

-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have not included the full name and/or mailing address for the vendor(s) listed. Please amend your report accordingly.

-Schedule H4 discloses several disbursements for the Phone ID Data (Event 10/22/94) events which appear to be using ratios inconsistent with those disclosed on Schedule H2. Please clarify this discrepancy.

-On Page 19 of the H4 Schedule, you show a total amount of \$71,865.30 paid to Great Lakes Communications for the 10/22/94 Phone Bank. However, the federal and non-federal shares total \$80,716.47. Please amend your report to clarify this discrepancy.

-Please clarify whether the debt(s) or obligation(s) listed on Schedule D of your report is owed to or by
