

U.S. Senate Financial Disclosure Statement



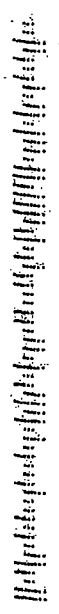
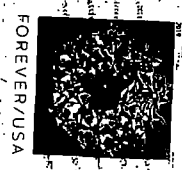
