This report lists receipts and disbursements incurred in conjunction with the annual Rockingham County/Harrisonburg City Banquet and Auction Fundraiser. In the past, this event has included a dinner, candidate speeches, a silent auction, and a live auction in order to raise money for Democratic campaigns. The Harrisonburg Democratic Committee has provided all accounting services for the event each year, and net receipts and disbursements were split on a 50%-50% basis between Harrisonburg and Rockingham. This year, donations were received as though people were buying tickets, the auctions were conducted through E-Bay, and speeches were broadcast on Zoom. Harrisonburg recorded the names of all donors and purchasers, deducted expenses for e-Bay, and Act Blue, and reported the net donations from each 'attendee' to Rockingham. The Auction and Banquet Ticket receipt amounts reported here are 50% of the amounts -- less E-Bay and Act Blue fees -- received from each individual.
