This is in response to your letter of June 28, 2000 (which we received on July 5), regarding the contributions to the Friends of George Allen.

Our report, covering the period 3/1/00 - 3/31/00, disclosed contributions of \$1,000 which were correctly shown as a contribution to the general election. However, the contributions for \$500 dated 6/17/99 (disclosed in the July 1999 monthly report) and \$4,500 dated 10/20/99 (disclosed in the November 1999 monthly report) should have been designated for the primary election and not the general election as stated in our report. We are filing an amended electronic report to reflect this change.
