Per the entry on Line 17: during this reporting period, CIPAC received an additional and erroneous receipt from a general payroll account which is being remediated. Specifically, on August 4, 2014 we received our usual beginning of the month contributions in the amount of 3,939.57. On August 6th, our payroll department duplicated this payment and inadvertently transferred an additional \$3,939.57 into the CIPAC bank account from a general payroll account. During our monthly account reconciliation, the PAC found the error and immediately notified our payroll department to remove the funds. On September 19th, our payroll department passed along a receipt which indicated the funds from the general account had been removed. After receiving confirmation from payroll that the funds were removed from the account and having received documentation, we spoke with FEC Analyst Brian Jones on 09/25/2014 to explain the situation. During the September account reconciliation, we found that our payroll department did not withdraw the funds as indicated but instead deducted the amount from the next employee payroll contribution. Per a follow-up call with Mr. Jones, we are now taking the recommended corrective actions.
