Referencing your letter of March 6, 1995 regarding an apparent overpayment or undesignated contribution to Senator Dole, please be advised that the problem has been corrected. A total contribution of \$10,000 to Senator Dole was reported during 1995. Of this, \$5,000 was undesignated on our report. Corrective action has been taken to change the status of this payment. Actual contributions for 1995 were for \$5,000 to Dole for President Compliance Fund and \$5,000 to Bob Dole Exploratory Committee. We have been in contact with Dole's campaign office regarding this matter (see attached) and corrective action has been taken.
