
Dear Mr. Ciaraldi:

This will confirm our telephone conversation of this date in response to your letter of May 19, 1999 regarding Line 6 of the Statement of Organization recently filed by the Republican Jewish Coalition Political Action Committee (RJC PAC). As I pointed out to you, the instructions for Line 6 in the FEC Campaign Guide specifically state to "check all boxes that apply" to the related organization. As I told you, that line is correct. The related organization, Republican Jewish Coalition, is indeed a corporation without capital stock and a membership organization.

You indicated that the letter was sent as a matter of course, merely because not many organizations check more than one box on Line 6. You told me to disregard your letter and that it would be removed from the public record as though it had never been sent.
