I am writing in response to your review of Independent Action's Mid-Year report.

Concerning our efforts to collect information from donors, I wish to establish that we are indeed making our best efforts to collect information from all of our donors including individuals who aggregate contributions exceed the \$200 threshold.

In every request made by our organization for a donation we ask that the donor provide the name of their employer and their occupation. I have enclosed copies of our request letters and response devices to demonstrate our efforts. Unfortunately, not all donors respond to our request. Please be advised that our year end report should reflect an increase in information on our donors, Also, we are internally reviewing all of our donors over the \$200 threshold, and we will mail a request specifically asking for this information from individuals who have not responded to our usual efforts.
