As was listed in the 2013 Year-End report, the contribution from CITIZENS FOR A BETTER EASTERN N.C. was determined to be excessive and was refunded on November 12, 2013 and reported in the 2013 Year-End report. The contribution listed in your letter from Orthocarolina P A Federal PAC is registered with the FEC under the FECID# C00471508. All other checks were vetted and additionally reviewed using their public disclosure filings to confirm permissibility. If any donors are subsequently found to not be permissible, the committee will take appropriate action.

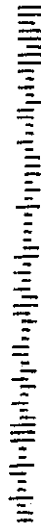
