Beginning January 1, 2007, the Federal Election Commission (FEC) will begin sending all courtesy materials to committees **exclusively** via electronic mail. If this address information is correct, no further action is required on your part. However, if this information is inaccurate or undisclosed, please amend your FEC Form 1 accordingly.

The Commission recognizes that disclosing a personal email address on a public document may raise privacy concerns. As the agency begins to communicate with committees electronically, keeping that email address current will be essential.
