All disbursements and expenditures for TELEMARKETING - NEGOP and NEGOP FUNDRAISING MAIL EXPENSE were for fundraising purposes for the state party only; no federal candidate or federal officeholder was identified in any of these events. No disbursements for rent appear on the report as the Nebraska Republican Party owns the building from which the organization operates and therefore does not make rental payments. Non-federal funds were not used in connection with any federal election or federal election activity.
