To Whom It May Concern:

This letter is to provide notice to the Commission that the above referenced Committee will function as a Hybrid PAC as that term has been defined by the Commission. Specifically, the Committee will establish a bank account into which FECA restricted funds will be deposited and expended to make direct or in-kind contributions, coordinated communications or coordinated expenditures to federal candidates and committees.

A second account will be established from which the Committee will exclusively make independent expenditures. Consistent with the U.S. Court of Appeals for the District of Columbia Circuit decision in Speech Now v FEC, and the stipulated judgment in Carey v FEC, the Committee intends to raise funds for this second account in unlimited amounts from individuals, corporations, labor organizations and/or other political committees. The Committee will not use the funds in this account to make contributions, whether direct, in-kind or for coordinated communications or coordinated expenditures, to federal candidates or committees.
