Per our telephone conversation on today's date, this amendment is being filed in response to your letter dated November 12, 2009. As we discussed, Dykema Gossett, PLLC files with the Internal Revenue Service as a partnership not a corporation. As such, we have not listed Dykema Gossett as a connected organization on previous Statements of Organization. However, in March of this year, all federal lobbyists were required to file amendments to their PAC's Statement of Organization indicating that it was a Lobbyist/Registrant PAC. At that time, we added Dykema Gossett and listed them as affiliated since they are not a connected organization. During our conversation today, you indicated that you would prefer that we list them as a connected organization even though they are not a connected organization, and that we file the amendment reflecting your request and clarify the relationship in additional memo text.
