This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The totals listed on Lines 11(a)(i) and 11(a)(ii), Column B of the Detailed Summary Page appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" (Column B) totals from your previous report to the current "Total This Period" (Column A) figures to derive the correct "Calendar Year-to-Date" (Column B) totals. Individuals who previously made unitemized contributions and now have exceeded the \$200 itemization limit should have their aggregate activity kept separate based on itemization. There should never be any fluctuation between unitemized and itemized Calendar Year-to-Date totals. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your amended report.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
