Consistent with the stipulated judgment in *Carey v. FEC*, this committee intends to establish a separate bank account to deposit and withdraw funds raised in unlimited amounts from individuals, corporations, labor organizations, and/or other political committees. The funds maintained in this separate account will not be used to make contributions, whether direct, in-kind, or via coordinated communications, or coordinated expenditures, to federal candidates or committees. The funds held in the separate account will be used to make independent expenditures consistent with the U.S. Court of Appeals for the District of Columbia Circuit decision in *SpeechNow v. FEC*.
