This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The total listed on Line 11(a)(iii), Column B of the Detailed Summary Page appears to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Line 11(a)(iii), Column B total.

-Please provide the totals for Lines 20 and 31, Columns A and B of the Detailed Summary Page. Also, please provide the total for Line 11(d), Column A of the Detailed Summary Page.

-Your report disclosed a line number total that has been reflected on the wrong line of the Detailed Summary Page. Committees operating one account (not allocating expenses between a federal and non-federal account) should be properly disclosing federal operating expenditures on Schedule B, supporting Line 21(b) of the Detailed Summary Page. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your next filing.


