This letter is to notify you that Chris Dahlberg did not receive the Republican Party endorsement at the convention on May 30th and has, therefore, pulled out of the race. He will not be participating in the primary election nor is his name on the ballot. As such, the Chris Dahlberg for US Senate Committee (C00550458) will not be filing the pre-primary report that is required of all candidates.

The Committee will remain open, however, as we are in the process of winding down, settling debts and the like. We will continue to file the quarterly reports for as long as we are winding down. Once we are ready to close the committee we will file the required Termination Report as required by the FEC.




