-Please clarify your relationship with New York State NARAL, Inc. which appears to be your connected organization. For further guidance on the question of connected organizations, please refer to 11 CFR §100.6. If New York State NARAL, Inc. is your connected organization, the full name of your connected organization must be included in the name of your political committee. While committees may use commonly recognized abbreviations on daily communications such as letterhead and committee checks, committee filings (Statement of Organization, disclosure reports and amendments) must reflect the official name of the connected organization, as well as any abbreviation, within its title. 2 U.S.C. §432(e)(5)

In addition, if your committee is a separate segregated fund, please amend your Statement of Organization to indicate the appropriate type of committee on Line 5(e).

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
