Environmental Defense Action Fund PAC (EDAF PAC) has received your Request for Additional Information dated August 5, 2020. You asked that we provide additional information regarding contributor information for donors on the July 2020 monthly report, and to describe in detail our procedures for obtaining contributor information. EDAF PAC has established procedures to obtain contributor information required by 11 CFR 104.7(b)(1). The procedures are as follows. First, EDAF PAC's original solicitation includes a clear and conspicuous request for the contributor information and informs the contributor of the requirements of federal law for the reporting of such information. (11 CFR 104.7(b)(1)) Second, if the information is not provided, EDAF PAC makes one follow-up, standalone effort to obtain this information, regardless of whether the contribution(s) was solicited or not. This effort will occur 30 days after receipt of the contribution and is in the form of a written request or an oral request documented in writing. (11 CFR 104.7(b)(2)) The request clearly asks for the missing information, without soliciting a contribution, informs the contributor of the requirements of federal law for reporting of such information, and if the request is written, includes a pre-addressed post card or return envelope. Third, if the contributor information is received after the contribution(s) has been reported, EDAF PAC either a) files with our next regularly scheduled report, an amended memo Schedule A listing all the contributions for which additional information was received; or b) files on or before our next regularly scheduled reporting date, amendments to the report(s) originally disclosing the contribution(s).
