We are requesting a refund of \$2,500 for the 2004 Primary election. The reason for the request is that I incorrectly designated on my July Quarterly Report (04/01/04 -- 06/30/04) a contribution of \$5,000, check # 5251, dated 4/19/04, as being for the 2004 Primary election. We had previously contributed \$2,500, check # 5161, dated 05/10/02, toward the 2004 Primary election. As a result of this, it appears as though our contributions are in excess of the limits set forth in the Act. 2 U.S.C. 441a (a). You correctly reported the \$5,000 contribution on your Pre-Primary report (04/01/04 -- 05/12/04) filed on 05/20/04 as being split between the Primary and General election. Neither of the checks had an election cycle designation printed on the memo line. This was simply a reporting oversight on my part and I cannot redesignate the contribution amount as I'm beyond the 60 day time period pursuant to 11 CFR 110.2(b).
