Thank you for your letter regarding the Indiana Chamber Congressional Action Committee's notification of multicandidate status FEC Form 1M. As you discussed on the phone with my colleague, Ashton Eller, on December 5, 2019, please accept this as notification that we have not yet reached fifty-one (51) unique individual contributors. We are currently at fifty (50) unique individual contributors.

I'd like to point out a few contributions that you and Ashton Eller discussed on the phone on December 5, 2019:

- John M. Blakley (contributed 10/22/2010) and Mike Blakley (contributed 10/12/2012) are the same person so should only count as one unique individual donor.
- Cal Burleson (contributed 3/3/2016) and D. Cal Burleson (contributed 1/20/2017) are the same person so should only count as one unique individual donor.
- Thompson Thrift Development Inc. (attempted to donate 8/21/2015) should not count as a unique individual donor because this contribution was refunded (refund made 9/18/2015)

The Indiana Chamber Congressional Action Committee will qualify as a multicandidate committee upon receipt of our next contribution from a new contributor. At that time, we will file a Form 1M.
