This letter constitutes formal written notification that A Lot of People Who Support Jeff Bingaman is filing reports of receipts and disbursements (FEC FORM 3) that appear to be for the 2012 election.

Further, candidates for both the Senate and House of Representatives are required to send a copy of their Statement of Candidacy or the information required therein, including the amount by which they intend to exceed the threshold amount, to each of their opposing candidates via fax or electronic mail.
