Proposed Activities:

Cleveland 2016 Host Committee Inc., an Ohio nonprofit corporation (the "Corporation"), will promote commerce within northeastern Ohio in and around the City of Cleveland, Ohio ("Cleveland"), and project a favorable image of Cleveland by participating in and preparing for the 2016 Republican National Convention. Specifically, the Corporation will conduct each of the following activities:

- (i) Defray the expenses incurred in the promotion of the Cleveland area as a suitable location for a national convention.
- (ii) Defray the expenses incurred in welcoming convention attendees to the Cleveland area by sponsoring information booths, receptions and tours of the area.
- (iii) Facilitate commerce, such as providing the convention attendees with shopping and entertainment guides and distributing samples and promotional materials.
- (iv) Provide administrative expenses incurred by the Corporation such as salaries, rent, travel and liability insurance.
- (v) Provide the use of an auditorium or convention center and provide construction and convention-related services for that location, such as: podiums; press tables; false floors; camera platforms; additional seating; lighting; electrical; air conditioning; loudspeaker systems; offices; office equipment and decorations.
- (vi) Provide various forms of local transportation services, including buses and automobiles, which will be provided through the Cleveland area's mass transit system and possibly through private donors or purchased from private vendors.
- (vii) Provide law enforcement services through agreements with local political subdivisions in and around Cleveland, which services are necessary to assure an orderly convention.
- (viii) Provide central housing and reservation services for convention attendees.
- (ix) Provide hotel rooms at no charge or a reduced rate on the basis of the number of rooms actually booked for the convention.
- (x) Defray the cost of providing accommodations and hospitality for committees responsible for choosing the site of the convention.
- (xi) Provide other similar convention-related facilities and services.



