On June 30, reconciliation identified a 6/16/2017 receipt that was not linked to an individual and a payroll error. A refund was issued to ADT Corp on 7/10/2017 for the 6/16/2017 receipt. An audit of payroll on 7/14/2017 identified a payroll file error where the receipt dated 6/16/2017 originally not linked to an individual record and considered to be a receipt from ADT Corp to ADT PAC, was in fact from an individual. The individual receipt was reported on the M7 FEC report covering 6/1/2017 to 6/30/2017. The 7/28/2017 refund of monetary contribution was a refund from ADT Corporation to ADT PAC for the 7/10/2017 refund of contribution for 6/16/2017 payroll error which was later determined to be a permissible receipt to ADT PAC.
