- Schedule A supporting Line 11(c) of your report discloses a contribution from "ANTHEM BLUE CROSS BLUE SHIELD FOR GOOD GOVT PROGRAM PAC.""CITIGROUP INC. STATE/FEDERAL PAC" and "JPMORGAN CHASE & COMPANY PAC." However, based on Commission records it appears that this contribution was actually received from "ANTHEM, INC. POLITICAL ACTION COMMITTEE (ANTHEM PAC)," "CITIGROUP INC. POLITICAL **ACTION** COMMITTEE **FEDERAL** (CITIGROUP "J.P. PAC-FEDERAL)" **MORGAN** CHASE & CO. **FEDERAL** and POLITICAL ACTION COMMITTEE," respectively. Please provide further clarification regarding this contribution so that it can be properly attributed. For your information and consideration for further filings, please file all future reports using correct names and identification numbers for contributions from other committees, where applicable.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will
