This amendment is being filed in response to an error noted in FEC letter of May 21, 2013. A contribution of \$5,125 was mis-classified as a political committee contribution in previous amendment. The previously amended return correctly included the following additional receipts, not included in the original filing: \$140,000 received 10/12/12, previously reported as 10/18/12 on Post General filing \$50,000 received 10/15/12, previously reported as 10/18/12 on Post General filing \$5125 in-kind contribution omitted from original filing. The corresponding disbursement was disclosed, but the in-kind aspect was initially omitted. All of these changes are intended to bring our disclosures into line with our reconciled bank statements. The initial omissions were unintentional.
