This letter is in response to your letter dated June 13, 2001, regarding the Air Line Pilots Association's Political Action Committee, ALPA-PAC, FEC Identification Number C000035451. Your letter raised a question, regarding our 30 Day Post-General Report (10/19/00 - 11/27/00). Specifically, your letter identified a contribution to a candidate for federal office in excess of the \$5,000 per election limit.

There was, in fact, an inadvertent excessive contribution of \$500 made to the Berkley for Congress campaign committee for the 2000 general election. We have notified the candidate of this oversight and have requested a refund of the excess funds. I am also enclosing a photocopy of the refund request. We will report the refund on the appropriate FEC report as per the instructions in your letter.

Dear Ms. Goldberg:

It has just been brought to our attention by the Federal Election Commission (FEC) that the Air Line Pilots Association's Political Action Committee (ALPA-PAC) and its affiliated PAC, the United Pilots Political Action Committee (UP-PAC) inadvertently exceeded the contribution limits for a multicandidate committee and its affiliates to make to a candidate for federal office. Specifically, our two PACs gave a combined total of \$5,500 to the Berkley for Congress campaign committee for the 2000 general election.

Because those contributions were made more than 60 days ago, we are requesting that the committee refund to ALPA-PAC the amount above the contribution limit, or \$500. The check should be made payable to ALPA-PAC and can be sent to ALPA-PAC, 1625 Massachusetts Ave. NW, Washington, DC 20036.

We sincerely regret this oversight, and apologize for your time and trouble in helping us rectify this situation. If you have any questions or need additional information, please feel free to contact Kelly Hardy of our staff at (202) 797-4033. She'll be available to assist you in any way.


