Dear Ms. Trainer:

I received your letter of September 30, 2005 and thank you for going over our report. You raised two questions:

1. We showed a \$5,000 contribution from Temple Beth El, which appeared to be a corporation. Due to my entry error, the contribution was incorrectly attributed to Temple Beth El. The contribution should instead have been shown as being from Richard Templer. I have amended the Mid-Year Report to reflect that he was the contributor rather than Temple Beth El.

As background for the mistake, I recently began using the FEC filing software. I entered all contributors and vendors as "people". We paid a small amount of rent to Temple Beth El when we held an educational program at that location. When I went to enter Richard Templer for the contribution transaction, it apparently cut off at Temple (which then showed Temple Beth Ed) and I did not notice the incorrect entry since I thought I had entered Templer as the contributor. We did not receive any contribution from Temple Beth El.

2. I did report an amount on line 25 "Coordinated Expenditures". As you surmised, it should have been reported as an in-kind contribution. I disclosed it on the wrong line. In the amended Mid-Year Report for the period ending June 30, 2005 I corrected the reference to Line 23.

Again thank you for reviewing our report and pointing out these two mistakes. I will be careful not to make them again.
