- Your amended report discloses an increase in receipts totaling \$13,166.97 from the amounts disclosed on your original report. Please amend your report or provide clarifying information as to why this activity was not disclosed on your original report. (11 CFR § 104.3)

The Commission notes the memo text attached to your report stating, "This amendment is to report receipts and disbursements that were erroneously not reported on the 2016 Q1 report." Although the Commission may take further legal action concerning this matter, your clarification and any additional clarification you may have will be taken into consideration. 11 CFR §104.3


