
Dear Mr. Dodson,

In reference to the FEC's request for information concerning the Florida Democratic Party's Amended April Quarterly Report (01/01/00 - 03/31/00 and amended on 06/25/00), dated April 4, 2001, please find as follows:

- Item 1. Schedule H2 indicates allocation ratio A019 Convention that was revised during the reporting period.**
- A. I submitted a letter, dated April 10, 2000, outlining a change to our allocation ratio which was due to the addition of two cabinet seats on the November 2000 ballot. The ratio for A019, event occurring in December of 1999, had previously been 43/57. The change in ratio revised A019 to 33/67.


