To Whom It May Concern:

We are writing this letter in response to a request from your office for further information surrounding a receipt that was reported on our Amended 12 Day Pre-General Report (10/2/06 – 10/18/06). The \$4000 shown on our report from "Fresno County Republican Central Committee" was in fact from our non-federal account. We issued the check from our non-federal account to our federal account after we realized that an entirely non-federal expense had been mistakenly paid from our federal account. The checkbooks are very similar in appearance and it was a complete oversight to write the check on the federal account. Because the expense was entirely non-federal it seemed as though the correct way to keep the books straight was to have the non-federal account reimburse the federal account. In accordance with the advice given in your letter, we have returned the money from the federal account to the non-federal account, and the documentation is provided. Please let us know if you need any further information. Proper compliance and full disclosure is very important to us and we are more than happy to assist you in clarifying this matter.
