
Reference: Cox Alomar 2012, Inc – Pre-primary Report

The Cox Alomar 2012, Inc. pre-primary report filed on March 6, 2012 listed a debt incurred of \$3,660 owed to Christopher Sanchez Ortiz. While his services would be commonly described as "field operation's services," the report employed a literal translation from the term commonly used in Spanish which is "escolta." This resulted in the use of the unsuitable term "escort services" which carries a different connotation in the English language.

To avoid any misunderstandings, the committee has decided to amend the Schedule to reflect the correct nature of the services provided.


