I am very thankful for the information that you gave me over the telephone yesterday in regard to our reporting requirements. As I mentioned, I had previously telephoned the FCC earlier this year to clarify our reporting requirements, and was told by one of your counterparts that non-connected committees did not need to file any reports until they had raised or spent \$1,000. I now understand that every committee must file reports after registering, regardless of whether they raise or spend a single cent.

I ask that our committee not be sanctioned with any penalties for not filing timely quarterly reports this year. We registered (prematurely) in March of this year, before taking any contributions or even adopting bylaws. We have bylaws now, but the only money we have received to date has been a \$50.00 contribution on July 31 to open our bank account. Our only expenditures have been two \$5.00 service charges to the bank for our monthly maintenance.

Now that we properly understand our reporting duties, I assure you that henceforth we will be reporting in a timely manner.

Thank you again for helping us get up to speed on our reporting requirements.
