Dear Ms. Kang:

I am writing in response to your letter dated January 30, 2002 regarding an excessive contribution by Genentech, Inc. Political Action Committee (ID#: C00199257) to Bayou Leader PAC on May 25, 2001 and improper descriptions of contributions.

Firstly, we have requested and received a refund in the amount of \$2,000 from the Bayou Leader PAC on February 22, 2002. Copies of the transmittal letter and refund check from the Bayou Leader PAC are enclosed. We will report this refund on Line 16 of our April 20 monthly FEC Form 3X report.

In the future, we will work closely with our affiliated PAC, Hoffman-LaRoche, Inc. Good Government Committee, to ensure that contribution limits are not exceeded.

Secondly, we have amended Schedule B, Line 23 of the Mid-Year Report for January 1, 2001 through June 30, 2001 to properly disclose contributions to the "Committee for the Preservation of Capitalism" and the "Keep Our Majority PAC". These contributions were not earmarked for James McCreery (LA-4-R) or Dennis Hastert (IL-4-R). Their names

have been removed and replaced with the accurate purpose of disbursement, "General Purpose Committee."


