Dear Mr. Morse:

Your April 17, 2013 letter inquires why the UAW Education Fund's (FED ID# C00528448) amended report disclosed an increase in receipts totaling \$195,000 that was not included in our original 2012 Post-General Report. The UAW Education Fund did not report the \$195,000 refund on our original 2012 Post-General Report due to an oversight. During the reportable time period, the UAW Education Fund made contributions to Working for Michigan PAC, a Michigan State Registered Independent Expenditure Committee. This expenditure was promptly reported on UAW Education Fund's 2012 Post-General Report. Working For Michigan refunded part of the contribution on November 9, 2012. Those responsible for filing the UAW Education Fund's FEC reports were not aware of the refund when they timely filed the 2012 Post-General report on December 5, 2012. In January 2013, the UAW Education Fund examined its bank records and discovered the refund was inadvertently unreported. The UAW Education Fund immediately corrected the mistake by amending its previous Post-General report to accurately reflect the refund as a receipt during the corresponding reporting period. The amended report is a complete and accurate account.
