Since 2011, Covington & Burling LLP PAC has made multiple prepayments to Covington & Burling LLP to offset potential staff time in excess of \$5,000. As of January 1, 2016, the pre-payment balance was \$904.31. On 4/29/2016, Covington & Burling LLP PAC paid Covington & Burling LLP an additional \$3,000 (Transaction SB21B.11941), bringing the combined prepayment balance to \$3,904.31. In this reporting period, the remaining prepayment balance is used to off-set \$1,217.23 in additional federal operating expenditures. The total funds retained by Covington & Burling LLP is now \$1,519.36.
