In April 2017 the ADT corporate payroll schedule was changed from bi-monthly to bi-weekly. In addition, the individual responsible for transferring the funds from ADT to the ADT PAC left the company after processing the wire for the 3-31-2017 payroll deductions. As a consequence of the change in the payroll schedule and payroll personnel, the 03-31-2017 employee payroll deductions were mistakenly deposited twice 03-31-2017 and 4-07-2017. Since the March 31 and April 21 payroll were in the same amount, but deposited on different dates, the second deposit was assumed to be a different payroll file. It did not become apparent until the reconciliation of the June activity that the second deposit was a duplicate deposit of the 03-31-2017 payroll deductions on 04-07-2017. An audit was conducted to make sure the second deposit was a duplicate and it was confirmed on July 14, 2017 that there had been a duplicate deposit. On July 17, 2017 a check was written from the PAC to ADT to refund the amount of the duplicate deposit.
