Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 item(s):

1. Schedule A supporting Line 15 of the Detailed Summary Page discloses a refund(s) or rebate(s) of what appears to be a previously disclosed allocated Federal Election Activity expense(s) from "Ambrosino Muir Hansen Crouse". Please be advised that when a committee receives a refund or rebate of an allocable expense, it must be allocated between federal funds and Levin funds according to the same allocation ratio used to allocate the original disbursement. Furthermore, the federal account must transfer the Levin portion to the non-federal or Levin account and disclose this transfer-out on Schedule H6. Your report does not appear to disclose a transfer-out of the Levin portion of this refund(s) or rebate(s). Please provide clarification regarding this apparent omission. (11 CFR §300.36(b)(2)(iii))
2. On Schedule H2, you disclose the ratio for "10-09-14 Event (ComEd) (10/09/2014)" to be the same as previously reported; however, it appears that this activity/event was not previously reported. Please amend your report to clarify this discrepancy. (11 CFR §§104.10 and 104.17)
3. The total listed on Line(s) 1(a), 1(c), 2, and 3, Column B of the Schedule L Aggregation Page for the "Democratic Party of IL Non Federal" account appears to be incorrect. Please be advised that you should add the "Column B Year to Date" total from your previous report to the current "Column A Total

This Period" figure to derive the correct Column B total. Please amend your report and any subsequent reports that may be affected by this correction. (52 U.S.C. §30104(b) and (e) (formerly 2 U.S.C. §434(b) and (e)))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
