Dear Ms. Grant

This is in response to your letter to the Mark Pryor for US Senate Committee, dated May 22, 2008, concerning the Committee's April Quarterly Report (1/1/08 – 3/31/08).

1) The Committee conducted a thorough review of the election-cycle-to-date totals itemized on Schedule B of our report and concluded that our numbers were correct. When I spoke with you on the phone, you indicated that it was difficult to accurately read the figures on the imaged copy of our report that had been provided to you, and, as a result, the data was misinterpreted. We provided you the proper totals, and it was agreed that the figures originally submitted to you by the Committee were accurate.

2) The election cycle-to-date totals for Wolf Block Fed. PAC are accurate. This PAC changed its name. It was formerly known as Tercentenary Fund, and its previous contributions to the Committee were reported as such. All entries were reported under the same FEC Identification Number, C00162719.

3) The sum of the memo entries on Schedule A, supporting the 3/31/2008 transfer from our joint fundraising committee, was less than the transferred amount reported on Line 12 because some of the memo entries had been reported on earlier transfers. However, during the Committee's review of this issue, it was discovered that one of the memo entries for the 3/31/2008 transfer had inadvertently not been included. The report has been amended to correct this error.

4) The Commission has requested that the disbursement "purpose" for Nesbitt Research Group, the Committee's research consulting firm, be changed and suggested "campaign strategy-research consultant." The Committee has made that change, and the report has been amended to reflect this.

We hope that this answers the issues raised in your letter. If you have any additional questions, or need any supplemental information, please do not hesitate to contact us.





