Individual sheriff deputies, employed by 65 separate sheriff offices statewide have contributed various small amounts each month to the PAC via payroll deduction (commonly \$2 per month but range from \$0.93 to \$51 in the aggregate per deputy for this reporting period; however, the number of deputies and their contribution amounts vary in each reporting period due to joining and quitting the PAC); There were 3,255 deputies that contributed during the 2nd Qtr. 2002 reporting period—the exact number of deputies for the 3d Qtr. are not yet available but the total unitemized amount reported is accurate. There are no individual deputies that have yet exceeded the \$200 reporting threshold during this reporting period. This amended Report has been filed due to amendments to our 2nd Qtr. 2002 Report as further explained in the Memo Text notes filed with that Report.
