RE: 30 Day Post-General Report (10/17/96 to 11/25/96)

Dear Ms. Wall:

I am writing in response to your letter of January 17, 1997, regarding the above-referenced report filed with the Commission by the Amalgamated Transit Union COPE Account -- Voluntary Fund (ATU-COPE).

On line 23 of our May 20, 1996, report, we erroneously listed a \$15,000 contribution, made on April 26, 1996, to the Democratic National Committee (DNC). In actuality, the \$15,000 contribution made on April 26 was made to a non-federal account of the DNC. As such, it should have been reported on line 29 of the May 20 report. Moreover, all of the subsequent 1996 monthly reports should have included the \$15,000 in the figure reported on Line 29 (not 23), column B of their summary pages. Because the April 26 contribution was erroneously reported as a federal contribution, the subsequent contribution of \$750 to the DNC's Federal Account appeared to violate the limits on federal contributions to party organizations. With the April 26 contribution properly reported, however, ATU-COPE's contributions to the DNC are within the statutory limits.



We hope these revised reports resolve any confusion regarding ATU-COPE's compliance with federal campaign finance laws.
