This letter is prompted by the Commission's preliminary review of the report referenced above. Please provide clarifying information regarding this discrepancy.
2. Itemized disbursements must include a brief statement or description of why each disbursement was made. Please amend Schedule B supporting Line 21(b) of your report to clarify the following description(s): "Distributing Invoices" and "Production." For further guidance regarding acceptable purposes of disbursement, please refer to 11 CFR 104.3(b)(3)(i).
