The payee entries for Peter D Hart Research Associates Inc on 10/15/08 which are reflected in this report represent travel costs associated with survey work the consultant completed at an earlier date, however, the vendor did not notify us of or provide an invoice for these additional costs until 10/15/08. The \$134.36 in travel costs attributable to Paul Kanjorski were associated with survey costs of \$41,000.00 that were originally reported on the 8/27/08 48 hour expenditure report; the \$591.12 in travel costs attributable to Jerry McNerney were associated with survey costs of \$42,000.00 that were originally reported on the 9/8/08 48 hour expenditure report; the \$656.34 in travel costs attributable to Ciro Rodriguez were associated with survey costs of \$42,000.00 that were originally reported on the 9/12/08 48 hour expenditure report.
