
Dear F.E.C.,

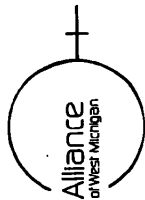

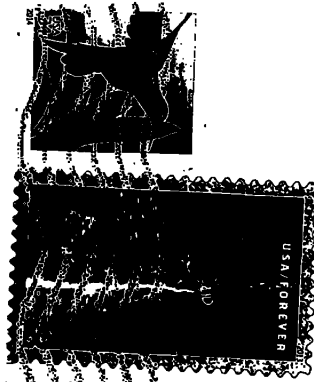
