This letter is response to your letter originally dated July 31, 2008 which was returned to you undelivered by the postal service. It was stamped "REMAIL" apparently on Sept 12, 2008. It was accompanied by a blue half-page sheet marked ATTENTION which suggested that my address might have changed. My address has not changed. I believe the difficulty was that the street address "110 Warbler Way" was omitted from your letter and we might have had a substitute carrier that day.


With respect to the main subject of your letter, the filing of the 2<sup>nd</sup> quarter report, I felt sure I had filed it. I had just finished answering a letter from Mr. Daniel Buckley and revising the 4<sup>th</sup> quarter 2007 report and thought I had prepared the 2<sup>nd</sup> quarter 2008 report. I normally take them to the post office so they can be sent by certified mail. I have searched my files to find my copy along with the certified mail receipt.

As I told your Rhiannon when I spoke to her by phone this afternoon, I did not find evidence that I had filed the 2<sup>nd</sup> quarter report by certified mail but instead found the report that I enclose herein that apparently never got mailed. Before I got to the post office to mail it I received a phone call early the morning of July 4 that my daughter had committed suicide. We had to go to Houston to make funeral arrangements. There was an autopsy by the state and her body was not released for almost a week. The burial did not take place until July 11, 2008. In all the confusion the prepared report got mixed up with some other papers and I forgot that it had not been mailed.

I am sorry for this oversight on my part, and I enclose the report with this letter. It is the same as the 1<sup>st</sup> quarter as there was no activity in this account for either quarter. There will be activity in the 3<sup>rd</sup> quarter report which is due to be filed by October 15, 2008.

I hope the circumstances causing this report to be late will permit you to accept it without penalty
