
This letter is to inform you that as of May 2, 2001 the Commission has not received your response to our requests for additional information dated April 11, 2001. These notices request information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to these requests (copies enclosed).

The Commission is in receipt of your letter dated April 21, 2001; however, it does not address the matters in the letter referenced above. An adequate response must be received at the Commission by May 23, 2001. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Dear Mr. Platt:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Pursuant to 11CFR §110.6 (c) all earmarked contributions that have passed through a conduit's account must be itemized on the receipt and disbursement schedules. Your report disclosed the receipt of earmarked contributions on Schedule A, but does not include any corresponding itemized disbursements on Schedule B. All earmarked contributions must be forwarded to the recipient candidate committee within 10 days of receiving the contribution. 11CFR §102.8(a) and (c). Please amend your report by providing the omitted disbursement schedules for all earmarked contributions disclosed by your committee. In addition, please amend your report to identify the designated candidate for the earmarked contributions disclosed on Schedule A.

-Your report discloses Memo Schedule A's totaling \$58,519.46 from the State Party Democratic Victory Fund. However, there are no corresponding transfers-in from this committee disclosed on Schedule A for supporting Line 12 of the Detailed Summary Page. Please clarify this apparent discrepancy.

-Your report disclosed certain categories of financial activity that have been reflected on the wrong lines of the Detailed Summary Page. Contributions from political committees and transfers from affiliated committees should


be properly disclosed on a separate Schedule(s) A, supporting Line(s) 11(c) and 12 of the Detailed Summary Page. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your next filing.

-Be advised that you have used an incorrect committee identification number on the Summary Page of your report(s). Please file all future reports and correspondence using your correct identification number, C00005561, to avoid potential errors in entering your reports onto the public record.

-You have received a contribution from Florida Marlins Baseball Club, LLC, which appears to be an unincorporated proprietorship or partnership. Generally, these types of contributions are to be attributed to each person based on their percentage of ownership in the firm. Each person who has contributed in excess of \$200 since January 1 should be identified by name, address, occupation, name of employer, amount of contribution, and aggregate total on Schedule A. 11 CFR §110.1(k) Please amend your report by providing the omitted information.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
