Please file an amendment to your report to correct the Column B discrepancies for this report and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the Calendar Year-to-Date totals. (2 U.S.C. § 434(b))
- **3.** Schedule A supporting Line 11(a)(i) of your report discloses receipts identified as "Items Unitemized."
