Dear Mr. Dobi:

This statement is in response to the Commission's letter dated May 13, 2021 regarding five (5) items.

First, the Commission's letter requests clarification regarding one hundred twenty-nine (129) contributors disclosed on the Original Report that appear to exceed federal contribution limits. As described below, all of those contributions were refunded to the contributors, returned to a joint fundraising committee ('JFC') in which the Committee participates for proper reallocation, or clarified as will be reflected on subsequent reports. Forty-two (42) contributors had their excessive contributions refunded. One (1) contributor had excessive contributions refunded to them but was reported with an incorrect election designation due to a clerical error. This will be corrected on the respective Amended Report. Eighty (80) of the contributors had their excessive contributions returned to the joint fundraising committee (Perdue Victory, Inc.- C00571620, Team Perdue - C00578542, or Senate Georgia Battleground Fund - C00736967) from which they came, to be reallocated to other JFC participants. The Commission identified two (2) excessive contributions from Non-Qualified PACs that appear to be Qualified Multicandidate Committees based on their Form 1Ms filed with the Commission. Four (4) contributions the Commission identified as exceeding federal contribution limits have been confirmed by the Committee as contributions by different individuals.

Second, the Commission's letter requests clarification on contributions from one (1) individual not refunded within sixty days due to the tremendous volume of contributions received by our Committee. This individual has been refunded.

Regarding Items Three and Four, the Commission's letter requests clarification on contributions identified as missing from 48 Hour Notices or appearing on duplicate 48 Hour Notices. One (1) contribution was timely filed, but the information in the report appeared blank due to a software glitch. This 48 Hour Notice has been corrected in an Amended report. 48 Hour Notices identified as duplicates have already been or will be corrected on Amended reports.

Fifth, the Committee has amended its report to clarify the purpose descriptions for the referenced Schedule B disbursements.
