This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:


-Schedule D of your report discloses two debts owed to Malchow, Adams & Hussey for direct mail consulting. In addition, your Schedule D discloses the payment this period for each debt to be \$70,201.73; totaling \$140,403.46 paid to this creditor. However, your disbursement schedules disclose only \$102,826.73 in payments to Malchow, Adams & Hussey. Please amend your report to clarify this discrepancy.

-Schedule A of your 1996 July Quarterly Report (pertinent portion(s) attached) disclosed a contribution(s) which appears to exceed the limits set forth in the Act. The Act precludes a political committee which is established and maintained by a national political party and any affiliated committees from accepting contributions in excess of \$20,000 in a calendar year from a person or political committee which is not a multicandidate committee. 2 U.S.C. §441a(f)

The Commission notes your refund(s) of the excessive contribution(s) disclosed on this report. Although the Commission may take further legal action concerning the acceptance of an excessive contribution(s), your prompt action in refunding the contribution(s) will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
